Project Updates		Rachel Dyer and Nancy Cronin walked the Council through the status of our ongoing projects.	
Health Care in Maine Status		<p>Nancy Cronin gave an overview of the history of the treatment of people in Maine with developmental disabilities, from town farms to institutionalization to community-based services. She then discussed ongoing service issues in light of the covid epidemic, including disruption to services, the higher risk for people with DD, and the dangers of congregate living.</p> <p>Nancy listed some things that exacerbate the gaps in healthcare people with DD experience, including communication issues, a lack of time and knowledge, and potential implicit bias in the system.</p> <p>Nancy also discussed issues around mental health for people with DD, and the specific difficulties people with DD experience in trying to get care for mental health issues.</p>	

		Finally, Nancy took a “1,000 foot view” of the systemic issues we need to focus on to make positive changes in this system, including looking at how the healthcare system interacts with other systems, including community supports and education.	
Quality Assurance Introduction		Rachel Dyer introduced the topic of Quality Assurance - much of our work is based in this, the systems work that improves experiences and outcomes for people with DD across service systems. How do we know that the services that people with DD receive are doing what we want them to? How do we measure quality and outcomes?

Council members broke into small groups in breakout rooms, to discuss their views on quality assurance, and how the Council can support systems change that improves quality in the systems that serve people with developmental disabilities. They then reported out on their conversations.
